**Authorized Wildlife**

Authorized to import species of Class III birds, non-venomous reptiles, amphibians and/or mammals (except capuchin, spider and woolly monkeys) for which the permittee is authorized to possess on their Permit to Possess Class III Wildlife for Commercial Use (ESC) and which are not native to the state of Florida.

**Permit Conditions**

IMP-III #1 This permit is only valid when held in conjunction with a valid Permit to Possess Class III Wildlife for Commercial Use (ESC) for the Facility Address specified above.

IMP-III #2 This permit authorizes the import of any Class III species of birds, non-venomous reptiles, amphibians, and/or mammals (except capuchin, spider and woolly monkeys) that the corresponding ESC license authorizes which are not native to the state of Florida. This permit does not authorize the importation of any species listed as Conditional or Prohibited in Chapter 68-5, F.A.C. This permit does not authorize the importation of any species in the family Cervidae in accordance with Rule 68A-4.0051, F.A.C.

IMP-III #4 The activities authorized by this permit may also require federal authorizations or permits. All applicable federal authorizations or permits must be obtained before engaging in any activity authorized by this permit and shall be provided upon request of Commission personnel.

IMP-III #5 Permittee shall notify the FWC, Captive Wildlife Section, within 72 hours of each import event authorized under this permit. Such notification shall be provided using the Captive Wildlife Import Reporting Form (<https://survey123.arcgis.com/share/6370a98097374198b0fb6fe587a5a0f7>) or by email to [CWApps@myFWC.com](mailto:CWApps@myFWC.com). Such notification shall include a complete and accurate report of each individual shipment. Such report shall include: the common and scientific name of each species imported; the number of individual animals of each species imported; the full name and address of the recipient; the full name and address of the out-of-state sender (if the sender is a broker, then the name and address of the point of origin of the shipment shall also be specified and provided); the method of transport; the name of transporter if ground transport is utilized; the date of entry of the shipment into Florida.

IMP-III #6 Any species requiring a permit for possession shall only be transported in the state of Florida by an individual permitted for possession of the wildlife being transported. Such permit shall be in possession of the individual(s) engaging in activity authorized by this permit and shall be available upon request by Commission personnel.

IMP-III #7 All wildlife authorized to be imported under this permit shall be safely and appropriately transported as provided in Chapter 68A-6, F.A.C.

IMP-III #8 This permit is subject to revocation at any time pursuant to Chapter 120, F.S. It is nontransferable and must be readily available for inspection at all times while engaging in activities authorized by this permit.

IMP-III #9 By accepting this permit, and by conducting the activities authorized hereunder, the permittee or designated representative agrees to assume liability for any and all damages, costs, or losses resulting from activities authorized under this permit. The permittee further agrees to indemnify and hold the Florida Fish and Wildlife Conservation Commission harmless from any and all liability, costs or damages resulting from activities authorized under this permit. If the permittee is a state agency or subdivision of the state, as defined in Section 768.28, F.S., the provisions of this paragraph shall be subject to that statute.

Explanation of Rights: A person whose substantial interests are affected by FWC's action may petition for an administrative proceeding (hearing) under section 120.569 and 120.57 of Florida Statutes. A person seeking a hearing on FWC's action shall file a petition for hearing with the agency within 21 days of receipt of written notice of the decision. The petition must contain the required information and otherwise comply with section 120.569, Florida Statutes, and the uniform rules of the Florida Division of Administration, 28-106, Florida Administrative Code. If the FWC receives a petition, FWC will notify the permittee.
